Nature of Certification System in Hong Kong

- □ Voluntary Scheme ISO is a high quality voluntary International Standards
- □ HKSAR as major customer demanding supplier to be ISO certified
- □ No requirement on Auditor (Competent of Auditor rely on CB)
- Quality Status (increasing/decreasing?)

Customer's expectation (responsibility)

- □ Need a paper ISO certificate or quality service/product? (Know the content?)
- Supplier with minimum performance or continuously improvement? (Training requirement)
- Quality level (requirement on quality personnel? (Standard rely on 3rd party, 2nd party or internal auditor?))

Guidelines for Auditing Management Systems

5.3.2 <u>Competence of the person managing the audit programme</u>

The person managing the audit programme should have the necessary competence to manage the programme and its associated risks effectively and efficiently, as well as knowledge and skills in the following areas:

- audit principles, procedures and methods;
- management system standards and reference documents;
- activities, products and processes of the auditee;
- applicable legal and other requirements relevant to the activities and products of the auditee;
- customers, suppliers and other interested parties of the auditee, where applicable.

The person managing the audit programme should engage in appropriate <u>continual professional development</u> activities to maintain the necessary knowledge and skills to manage the audit programme.

H K Practice (Product Scheme)

QSPSC Product Scheme

Auditor: A nominee of the Certification Body appointed to carry out Assessments.

Auditors who are eligible for auditing QSPSC must have the following training, experience and qualifications:

- Qualified IRCA or IATCA QMS auditor when performing audit in Hong Kong and Macau;
- Qualified CNAT QMS auditor when performing audit in China;
- With minimum one year concrete industry experience, or minimum one year quality management system audit experience for concrete industry;
- <u>With relevant Higher Diploma in architecture</u>, building, structural and civil engineering, or other related construction field.

Other Product Schemes

Auditor: A nominee of the Certification Body appointed to carry out assessments.

Auditors are classified as Lead and Technical Auditors.

- 13.1 <u>Lead Auditors</u> who are eligible for auditing PCCS-CP quality management system shall have the following registration: <u>Registered IPC or Hong Kong Institution of Certified Auditors (HKICA)</u> Lead Auditor in QMS or equivalent.
- 13.2 <u>Technical Auditors</u> who are eligible for auditing PCCS-CP technical management system shall have the following training, experience and qualifications:
 - Registered HKICA Product Certification auditor in relevant fields or equivalent,
 - <u>A relevant Higher Diploma in architectural studies</u>, building, materials science, structural or civil Engineering, or other related fields, and;
 - With a minimum of two years xxxxx industry technical experience, or a minimum of two years quality management system audit experience for xxxxxx manufacturing industry or with appropriate training held by or

Competence (BS EN ISO 9000:2015 2.2.5.3)

A QMS is most effective when all employees understand and apply the skills, training, education and experience needed to perform their roles and responsibilities. It is the responsibility of top management to provide opportunities for people to develop these necessary competencies.

Engagement of people (BS EN ISO 9000:2015 2.3.3.1)

<u>Competent</u>, empowered and engaged people at all levels throughout the organization are essential to enhance the organization's capability to create and deliver value.

- ensure people are competent to analyse and evaluate data as needed;



Standard for Certification of Persons : ISO/IEC 17024

- "Has been developed with the objective of achieving and promoting a globally accepted benchmark for organizations operating certification of persons"
- "... This international standard can serve as the basis for the recognition of the certification bodies for persons and the certification schemes under which persons are certified, in order to facilitate their acceptance at the national and international levels."

Certification of Persons in 17024: 2012 Revision



- *"Certification of Persons"* instead of "Personnel Certification" and *"Certification Body for Persons (CBP)"* instead of *"*Personnel Certification Body (PCB)". **Reason:** *"Personnel"* is defined and translated as employee. New term *Certification of Persons* and *Certification Body for Persons* is so everybody will understand that this is certification of people (not employees).
- General Personnel Requirements (6.1) Clauses pertaining to competence, training and signing of conflict of interest and confidentiality agreements added.
- Principles section added in Annex A. Includes principles associated with impartiality, competence, confidentiality and openness, responsiveness to complaints and appeals, and responsibility.
